

VIETNAM ADDENDUM TO GLOBAL PRIVACY POLICY

This Vietnam Addendum to Global Privacy Policy (“**Addendum**”) applies where the Policy and this Addendum are used for our processing of your personal data pursuant to Vietnam’s personal data protection regulations, including Law No. 91/2025/QH15 of the National Assembly dated 26 June 2025 on Personal Data Protection and its guiding documents, as amended from time to time (“**Vietnamese Data Protection Regulations**”). This Addendum supplements the Policy from the perspective of Vietnamese law and constitutes an integral part of the Policy. Unless otherwise specified herein, this Addendum will prevail over any conflicting provisions of the Policy and amendments thereto (if any). Other sections of the Policy that are not amended hereunder will remain unchanged.

Within the scope of this Addendum, depending on the type of personal data and the purposes for which such personal data is processed, we may act as a **personal data controller** or as a **personal data controller and processor** and will have the corresponding rights, obligations, and responsibilities in accordance with the Vietnamese Data Protection Regulations, including the responsibility to ensure your lawful rights as a data subject.

1. Sensitive Personal Data Obtained by Us

Notwithstanding anything to the contrary contained in Section 2 (Personal Data Obtained by Us) of the Policy, among the types of personal data listed in Section 2 (Personal Data Obtained by Us) of the Policy, for your awareness, the following might be classified as sensitive personal data under the Vietnamese Data Protection Regulations:

- **Products and Services Data**

Information related to products and services you have purchased (including products and services you intend to purchase) (including

information regarding the status and use of products, location information, service history, and store of purchase);

- **Technical Data**

Technical data, including access data, Internet protocol (IP) address, your login data, browser type and version, time zone setting and location, browser plug-in types and versions, operating system and platform, and other technology on the devices you use to access this website;

- **Usage Data**

Information about how you use our website, products, and services.

- **Marketing Data**

Your preferences in receiving marketing from us or the third parties engaged by us and your communication preferences;

With respect to this category of sensitive personal data, we will process such data with a higher and more stringent level of care compared to the processing of other personal data. In particular, we will establish access-control and authorization rules, data processing procedures, and appropriate security measures corresponding to the relevant processing activities, such as the application of physical security measures for storage and transmission devices, encryption measures, anonymization of personal data, and other security measures during data transfer.

2. Your Additional Rights and Obligations

- a. In addition to the rights listed in Section 9 (Your Rights) of the Policy, you have additional rights granted by the Vietnamese Data Protection Regulations that will prevail over those in Section 9

(Your Rights) of the Policy in case of any conflicts or overlaps, as follows:

- (i) the right to be informed about processing activities involving your personal data;
- (ii) the right to consent or withhold consent, and to request the withdrawal of consent, to the processing of your personal data;
- (iii) the right to access, review, correct, or request correction of your personal data;
- (iv) the right to request the provision, deletion, or restriction of processing of your personal data, and to submit objections to the processing of your personal data;
- (v) the right to complain, denounce, or initiate lawsuits and to claim compensation for damages in accordance with applicable laws; and
- (vi) the right to request that competent authorities or relevant agencies, organizations, or individuals involved in the processing of your personal data implement measures and solutions to protect your personal data in accordance with law.

In respect of your inquiries or requests in relation to exercising your data subject rights or any other matters relating to the protection of personal information, we will inform you of the procedures for exercising your data subject rights and will process your requests in accordance with the applicable procedures, processes, and forms as issued and amended by us from time to time and in accordance with the Vietnamese Data Protection Regulations.

- b. In addition to the rights to your personal data, you have certain obligations, including, but not limited to, the following obligations:
- (i) to take measures to protect your personal data;
 - (ii) to respect and protect the personal data of others;
 - (iii) to provide complete and accurate personal data in accordance with law or with the relevant contract, or when giving consent to the processing of your personal data; and
 - (iv) to comply with laws on personal data protection and participate in the prevention and combat of acts infringing upon personal data.
